MEMORANDUM OF UNDERSTANDING श्री. दि. नं. गुवर्द्ध

This Memorandum of Understanding (hereinafter referred to as "MoU") is made on this 30th day of July 2021 at Mumbai by and Between M/s. Hare Krishna Movement Charitable Foundation (HKMCF) registered as a Public Charitable Trust bearing registration number CS24/2013 book no. 1V/18/2013 (Hyderabad) having its working office at: D-401, GHP Trinity, Hignandani Hospital Road, Powai, Mumbai - 400 076 and Director (ME&MH) & Dean (B.Y.L. Nair Ch. Hospital), Dr. A. L. Nair Road, Mumbai Central (East), Mumbai - 400 008

Article 1: Brief Description of Project

HKMCF has approached Municipal Corporation of Greater Mumbai (MCGM), Government of Maharashtra and proposed that it will serve FREE meals during lunch time 12 noon to 2 pm to attendees of patients in Government hospitals like BYL Nair, KEM, Kasturba, Lokmanya Tilak and other MCGM run government hospitals in Mumbai region.

Article 2: BYL Nair Ch. Hospital, Mumbai, Maharashtra, hereinafter referred to as "Nair Hospital" represented by Dr. Ramesh Bharmal, Dean and Director – Nair Hospital, Director – Medical Education and Major Hospital (MEMH). The main objective of the Nair Hospital is to look after matters of medical education in running medical college, patients' health care and research in the said institute.

Article 3: Brief Background of Partner

HKMCF registered as a Public Charitable Trust bearing registration number CS24/2013 book no. IV/18/2013 (Hyderabad) having its principal office at: Sy. No: 172, Goldenmile road, Kokapet, Narsingi, Hyderabad – 500075. It has engaged in various charitable initiatives and activities. Hare Krishna Movement also has initiatives like Akshaya Patra which provides mid-day meals in Government schools

Article 4: Role of Partner

HKMCF will serve 6000 FREE meals during lunch time 11 am to 2 pm to attendees of patients in Government and MCGM hospitals like BYL Nair, KEM, Kasturba, Lokmanya Tilak, and other such MCGM hospitals in Mumbai. All CAPEX and REVEX for providing meals will be borne by HKMCF.

Article 5: Role of Hospitals

Hospital management to provide a designated place within the premises of the hospitals to serve food for under-privileged people in a dignified manner. Hospital management to provide basic facilities like hand wash, drinking water, dustbins etc. at the place where food is served

Article 6: Any research / document arising out of the implementation of this MOU shall be jointly authored by both the parties.

Article 7: Non-binding MoU for future cooperation

This MOU describes the general conditions and arrangements for further progress between the parties and is non-obligatory. Neither party shall be liable to the other for any claim, loss, cost, liability or investment opportunities arising out of it directly or indirectly. This MoU is therefore not enforceable in any court of law.

Article 8: Duration and termination

This MOU shall remain in effect for a period of 36 Months from the effective dates and can be terminated in writing by either party at any point of time with a notice of 30 days. The MOU can be further extended to such further time not exceeding another 36 months as per mutual understanding between the two parties.

Article 9: Terms and Conditions:

1. The parties hereto agree that the terms and conditions of the MOU and other confidential information shall not be disclosed to any third party without prior consent in writing from the non-disclosing party, unless such disclosure is required by law.
2. Notwithstanding anything to the contrary in the MOU, neither party hereto shall be liable for reason of failure or is delay in the performance of duties and obligations under the MOU if such failure or delay is caused by an event of force-majeure.
3. Either parties reserve its right and is entitled to enter into similar MoUs with other parties and opposite party shall have no objections for the same.
4. H.K.M Charitable Trust on temporary basis to provide free meals to the relatives of patients admitted to the MCGM's B.Y.L. Nair Ch. Hospital.
5. The Organization will be allotted a special place in the premises of B.Y.L. Nair Ch. Hospital for the above purpose.
6. They will supply packets of cooked food in a closed form at the designated place and their staff will be provided with drinking water.
7. Neither the organization nor its staff will behave in a way that will interfere with any administrative work of the hospital. Also, they will not claim the assigned place in the hospital in any way in future.
8. It is necessary to conduct a medical examination of the staff of the organization handling the food and submit an updated certificate to that effect.
9. The Hospital Administration will not be held responsible for any dispute over the quality and hygiene of the food.
10. Municipal Corporation of Greater Mumbai will not be financially involved in this scheme in any way.

11. In order to comply with the above-mentioned terms and conditions, the organization will complete the process of concluding a Memorandum of Understanding with the Municipal Corporation of Greater Mumbai.
12. In case of violation of the above-mentioned terms and conditions, if any inappropriate matter is found, orders will be issued to stop the services without giving any prior notice to the organization.
