MEMORANDAM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter referred to as "MoU") is made on this 11th day of February 2019 at Mumbai By and Between M/s. Hare Krishna Movement registered as a Public Charitable Trust bearing registration number E-6225 (Thane) having its working office at: D-401, GHP Trinity, Hiranandani Hospital Road, Powai, Mumbai – 400 076 and Governor of the State of Maharashtra exercising executive powers of the Government of Maharashtra through Secretary, Medical Education and Drug Department having office at 9th Floor, New Mantralay, G.T. Hospital Compound, Mumbai 400001.

Article 1: Brief Description of Project

Hare Krishna Movement has approached Medical Education and Drug Department, Government of Maharashtra and proposed that it will serve FREE meals during lunch time 11 am to 2 pm to attendees of patients in Government hospitals like Cama Hospital, JJ Hospital, GT Hospital and St George's hospitals in Mumbai.

Article 2: Medical Education and Drug Department, Government of Maharashtra, hereinafter referred to as "The Government" represented by Dr. Sanjay Mukherjee, IAS, Secretary, Medical Education and Drug Department (MEDD). The main objective of the MEDD is to look after matters of medical education in the state running medical colleges, patients' health care and research in the said institutes.

Article 3: Brief Background of Partner

Hare Krishna Movement registered as a Public Charitable Trust bearing registration number E-6225 (Thane) having its principal office at: No 21, Siddhivinayak Society, Sector 21, Opp Nerul Station East, Navi Mumbai – 400 706. It has engaged in various charitable initiatives and activities. Hare Krishna Movement also have initiatives like Akshaya Patra which provides mid-day meals in Government schools.

Article 4: Role of Partner

Hare Krishna Movement will serve 4000 FREE meals during lunch time 11 am to 2 pm to attendees of patients in Government hospitals like Cama Hospital, JJ Hospital, GT Hospital and St George's hospitals in Mumbai. All CAPEX and REVEX for providing meals will be borne by Hare Krishna Movement.

Article 5: Role of MEDD

To provide around 3500 sq feet of space in any one of the four hospital where it can set up a small kitchen to cook and deliver the FREE lunch meals. All CAPEX and REVEX will be borne by Hare Krishna Movement. All rights of this land shall remain with MEDD.

Article 6: Any research / document arising out of the implementation of this MoU shall be jointly authored by both the parties.

Article 7: Non-binding MoU for future cooperation

This MoU describes the general conditions and arrangements for further progress between the parties and is non-obligatory. Neither party shall be liable to the other for any claim, loss, cost, liability or investment opportunities arising out of it directly or indirectly. This MoU is therefore not enforceable in any court of law.

Article 8: Duration and termination

This MoU shall remain in effect for a period of 36 Months from the effective dates and can be terminated in writing by either party at any point of time with a notice of 30 days. The MoU can be further extended to such further time not exceeding another 36 months as per mutual understanding between the two parties.



Article 9: Terms and Conditions:

1. The parties hereto agrees that the terms and conditions of the MoU and other confidential information shall not be disclosed to any third party without prior consent in writing from the non-disclosing party, unless such disclosure is required by law.
2. Notwithstanding anything to the contrary in the MoU, neither party hereto shall be liable for reason of failure or is delay in the performance of duties and obligations under the MoU if such failure or delay is caused by an event of force-majeure.
3. Either parties reserves its right and is entitled to enter into similar MoUs with other parties and opposite party shall have no objections for the same.
